On behalf of the Committee, I welcome the Leonard Education Organization to its network of civil society organizations active on the question of Palestine.

NGOs shall respect the United Nations rules of procedure, as well as the guidelines, procedures and practice established by the Committee. Finally, they are encouraged to submit periodic reports to the Division on their planned and accomplished activities.

Your organization has been added to the mailing list managed by the Division for Palestinian Rights, and you should soon receive periodic mailings of United Nations publications on the question of Palestine and information distributed in electronic form, such as NGO Action News, and a weekly newsletter that lists NGO activities around the world. 
